The company is a *woman-owned small business* as defined by the Small Business Administration (SBA). Our EIN is 46-0653147, and our CAJE Code is 6K0D0. We are registered in SAM.

GMCS requires that all its employees and subcontractors be certified Lead Auditors through the International Registry of Certificated Auditors (IRCA).

GMCS is accredited by the International Accreditation Service (IAS). IAS is a nonprofit, public-benefit corporation that has been providing accreditation services since 1975. It is a member of Asia-Pacific Laboratory Accreditation Cooperation (APLAC), International Laboratory Accreditation Cooperation (ILAC), International Accreditation Forum (IAF), and the Pacific Accreditation Cooperation (PAC). IAS accreditation is equivalent to American National Accreditation Board (ANAB) accreditation because both IAS and ANAB are members of the IAF with a scope that includes management system certification. IAF members agree to accept each other's accreditations as equivalent.

The core focus of GMCS's business is provide third party certification services for quality management, environmental management, and social accountability standards including ISO 9001, ISO 13458, ISO 15378, ISO 14001, ISO 20000-1, and ISO 27001, GMCS is accredited to ISO 17021 and complies with ISO 9001 and the accreditation requirements of IAS.
